

## SMART TRACKER GIVEAWAY SWEEPSTAKES

### OFFICIAL RULES

1. **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. 1. **KEY DATES:**

Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason.
